

MOTION TO UNSEAL SECRET MATERIALS FILED JUNE 8, 2007

Plaintiffs-Appellees hereby move for the unsealing of secret materials filed by Defendants-Appellants on June 8, 2007, for the reasons discussed more fully in Plaintiffs-Appellees' Memorandum of Law in Support of Motion to Unseal Secret Materials, dated January 26, 2007 and Plaintiffs-Appellees Motion to Unseal Secret Materials Filed April 6, 2007. Once again, neither the June 8th Notice of Lodging nor the government's Third Updated Listing of Classified Items Filed to Date in this Case provides any substantive information about the secret materials. The only information provided is that two classified documents have been filed: a classified submission and a classified declaration by defendant Lt. Gen. Alexander. There is nothing in the public record to indicate the import, form, content, or length of the submission or declaration.


